2012 was an exciting walking year as we explored and walked in several new WI counties. Some of us cannot wait for 2013 to start. Right now many behind the scenes folks are making plans to insure 2013 is as exciting and enjoyable as our most recent experiences in Calumet & Sheboygan counties.

Our next two county walking week end is scheduled for April 20th & 21st for Outagamie and Waupaca. On Saturday April 20th Mary & Tony Liebig will lead us off with a walk in historic downtown Appleton and Nancy & Ron Wight will follow on Sunday the 21st with a walk in the city of Waupaca, located on the famous WI Chain 'O Lakes.

As dates on the calendar are ALWAYS closer than they appear, please mark your 2013 walking plans now in/or on whatever you use to remind yourself far enough in advance so we don't hear someone say, "Oh my gosh, there is a walk next week end?!" AND speaking of plans: Bruce Dewey has made arrangements for us to use a B&B in Rural, WI. This beautiful old farm house has accommodations for 22, with 1 king, 9 queens and 2 single rooms. We have visited and some of us have even stayed there on previous excursions into Waupaca county. We have a deadline of March 31st to fill the rooms.

Also I have made arrangements for a bus for this weekend. Itinerary as follows:

Friday April 19th: Depart Madison area park 'n ride after work??? Stop for supper along the route to B&B. Arrive B&B by 9pm.

Saturday April 20th: depart B&B 8:30 to Appleton walk, approx. 1 hour. Depart Appleton 2pm after lunch. Arrive B&B and stroll Rural, optional 5K led by Carol Clarke and Nancy Spaeni. Wait until you see this 'postcard' little community. Then bus to Waupaca for dinner, TBD.

Sunday morning return to Waupaca for walk and depart for home after lunch by 12:00 pm. Hopefully arrive Madison NLT 2pm.

Cost: \$60.00 per person, minimum 25 riders. If more, cost will reduce. All kids under age 18 ride FREE! All riders not staying at the B&B will be delivered/picked up at Waupaca area motels.

Welcome (Doug)

The meeting was called to order at 6:00PM by President Doug Wiest and the agenda was adopted. Also in attendance were Karen Reger, Tom McCrill, Cindy Haagensen, and Barb Lund.

Treasurer's Report (Kristi)

Kristi had emailed the Treasurer's Report to the Board. The balance on August 8, 2012 was \$17,007.67. Since that time, income totaled \$5,661.00 and expenditures were \$13,344.05. The current balance on September 12, 2012 is \$9,324.62. Of that balance, \$5,391.03 is restricted for trips. Income was higher than normal due to the final Mackinac Bridge bus trip deposits. The expenses included the second quarter participation and processing fees for year round and seasonal walks and many of the bus trip expenses. The Treasurer's report was accepted and filed for audit.

Meeting Minutes (Mary)

The minutes of the last Board meeting held on July 11th 2012 had been previously emailed to the Board. There were no corrections or additions to the minutes, and they were approved as distributed.

Director at Large Report (Barb)

Barb had nothing to report.

Trailmaster (Don)

Don wants to talk to Gilbert Engel of the Menominee River Volkssport Club about developing a seasonal walk in Green Bay on the Packer Heritage Trail. Don sees no opening in the Dairyland Walkers schedule for a one day event in Green Bay in the next few years. Don will put Gilbert in touch with club member Pete Nagan who has already mapped out a walk on the Packer Heritage trail.

Don also informed us that the Superior, WI seasonal walk sponsored by the Twin Cities Volkssport club will only be available through 2013. After that, POC Gary DeVore would like to develop a seasonal walk in Bayfield. Don would like to talk to Gary about developing a walk in Ashland as well in 2014.

The Board granted Don permission to talk to Gary about a walk in Ashland as well as Gilbert about a walk in Green Bay.

On another note, Don told the Board that the directions to High Cliff State Park walk will need to be revised due to some construction. Don will inform Bonnie Hamer so she can include the updated directions to High Cliff State Park in an email. Russ Crane will also update the club website for the new directions. The Maywood Environmental Park walk in Sheboygan is the day after the High Cliff State Park walk. Don mentioned that the Maywood Park has a very nice kitchen and he wondered if any of our members would like to arrange for food to be served after the walk. He is unable to take on the task himself.

Don then passed out his final draft of the 2013 walk schedule. Doug Weist made a motion to approve the 2013 schedule, the motion carried. Don will send our 2013 walk schedule to neighboring AVA clubs such as Des Moines, Twin Cities, Windy City, and Lake Country Wanderers.

Webmaster Report (Russ)

Russ presented the Usage Report from July 2, 2012 to September 10, 2012 and gave a short explanation of the numbers. The number of visits is on track with previous years.

New Business

North Central Regional Conference 2014.

Russ Crane said that Phyllis Olson, our AVA Regional Director, had approached him about the Dairyland Walkers hosting a regional conference in 2014. Russ outlined what the regional conference would involve:

- Three or four Walks
- Hotel space for about 100 people
- One meeting
- Meet & Greet Friday night
- Dinner on Saturday night with program

Our club would need to make a decision on hosting a 2014 regional conference in the next couple of board meetings. Don Suloff made a motion to include this as an agenda item at the November board meeting, the motion was approved.

Recognition of Service Awards

At each AVA convention, regional directors hand out recognition of service awards. In seventeen years, only once has our club submitted nominations for recognition of service. Russ Crane stated that we should do this on a regular basis. The nominations for the 2013 AVA convention need to be submitted by November; Russ Crane will submit names of club members by this time.

Special Reports

Constitution Committee (review and update of DLW Bylaws)

Tom McCrill and Russ Crane reviewed and made minor changes to the Bylaws of the Madison Area Volkssport Association (a.k.a. Dairyland Walkers). Their proposed draft was presented to the Board. After one slight change to Article VIII, Vacancies in Office, Section 1, Don Suloff made a motion to have the Board approve the bylaws as amended. Barb Borde seconded the motion and the motion was approved.

Nomination Committee (for 2013 board members and officers)

Liz Odgren, Tricia Gundlach, and Tom McCrill served on the nomination committee for 2013 board members and officers. There are four people interested in serving as the Board Member at Large next year: Diane Thornbery, June Quesnell, Barb Lund, and Terry Wendt. All other current officers are interested in serving again next year.

Doug Wiest will send these nominations, as well as the updated bylaws, to Jerry Wilson to send out in a club email to members by September 26. Doug will also check with Gwen Kraemer to see if she has reserved the Middleton Library for the October 10 membership meeting.

The next Board Meeting will be November 14, 2012 at the Lakeview Branch Library. The next membership meeting (annual meeting) will be held on October 10. The next walking events will be the Monroe Cheese Days Walk on Saturday, September 15 and the Two County Weekend events in Sherwood and Sheboygan on October 13 and 14.

Meeting

President Wiest called the meeting to order at 6:30pm. There being no additions or corrections to the agenda previously emailed to the Board, the agenda was adopted.

Meeting Minutes (Mary Liebig)

There being no additions or corrections to the minutes of the membership meeting held on August 8th 2012, they stand approved as previously emailed to the Board.

Treasurer's Report (Kristi Kenyon)

The report was previously emailed to the Board. The report noted negative income of \$63.00 and expenses of \$4,468.10 since the previous report. Current balance is \$4,793.52. Of this balance, \$1,000 is restricted for trips. The negative income is due to the refunding of overpayments made for the Mackinac Bus trip. The report was accepted and filed for audit.

Old Business

Membership Renewals

Now that the club has an electronic newsletter, club-members no longer have a reminder mailed to them to pay their yearly membership dues. A question was then raised, should club-members pay their membership dues once a year, all the same time, or should email reminders be sent to members when their renewals are due? Kristi was asked if there would be a problem with our budget if all membership renewals came in as income at the same time. She said she saw no problem with that. After some additional comments, it was decided to discuss this issue at a future Board Meeting.
