Donald County Park Walk – August 23rd By Dave and Kim Riyeff

"There is strength in the hills and peace in the valleys." - Delma Donald Woodburn

In the 1850's the Rev. James Donald and his family settled in a log cabin just north of what is now Hwy. 92, near Mt. Horeb. In 1859 they completed a two story farmhouse which still stands on the site of the Donald farm. The family continued to farm the land. James' great-grand daughter, Delma, married, lived in several states, and in Germany. All the while, she remained deeply attached to the farm. In 1993 her family donated 105 acres of Donald property to Dane County Parks. Over the years, Dane County has acquired an additional 475 acres of new lands for the park.

The Dairyland Walkers are sponsoring 10K and 6K walks in beautiful Donald County Park on August 23, 2014. The walk will begin at Delma's Shelter at the Pop's Knoll entrance to the park, just off Hwy. 92. Starting time: 8:00 AM to 12:00 noon. The walks will take us through woodlands, wetlands, and restored prairie. Part of the trail visits a historic cabin site. There are sections of the route that are on hiker only trail, but we also share some trail with folks on horseback. (See Attachment E, page 17.)

The walk is rated 2B...there are some climbs. We're looking forward to seeing you all in August. The extended weather forecast for that day is for sunny skies, temperatures in the low 70's with no humidity!! Guaranteed !! :)

County Make Up Program By Don Suloff

The following is a reprint of an article in last October's newsletter for any who may have missed it.

It was inevitable that some club members would miss county walks conducted since we initiated the program in 2007. Other walkers are participating in the program, but have joined the club subsequent to 2007. It is not realistic to repeat these walks while our efforts are focused on completing the program, nor is it cost effective to sanction walks anticipating only a few walkers to participate in a walk. Recognizing the benefit to the club of maintaining a high level of interest in the county walking program and the benefit to interested members of establishing a mechanism whereby county walks conducted in past years can be completed and credited in the county walking booklet, the Dairyland Walkers have determined to grant credit for such walks providing the participants understand potential problems and follow the special rules described below.

Although maps and directions for past walks are (for the most part) available, some of these walks may be difficult without guiding arrows. Furthermore, it will also be difficult or impossible to verify that no route changes have occurred subsequent to our first conducting the walk. Walkers wishing to participate in a "make-up" walk must be aware of such potential problems and be "flexible" when necessary. It is strongly recommended that at least two individuals walk together on all walks. In some cases it will be desirable to reach the walk in more than one vehicle since the original walk was a lineal walk rather than starting and finishing at the same location.

Stamps will not be necessary since the county walk program is applicable only to our club. Of course, this would mean that AVA credit will not be available to those doing these "make-up" walks. The club will develop a "stick-on" strip which will be made available on completion of each "make-up" walk and will be placed on the appropriate line(s) of the "Walking the Counties of Wisconsin" booklet. As with many AVA walking programs, there will be the assumption of individual integrity in actually completing the "make-up" walks.

The club trailmaster will be the point of contact for these walks and will provide maps and directions to individuals wishing to participate in a "make-up" walk, secure signatures on a liability waiver form, and issue the "stick-on" strip once the walk has been completed. Completed walk claims should be presented to the trailmaster at a Dairyland Walker special event. Since "make-up" walks are not sanctioned, there will be no fee for completion of such a walk, but individuals will be encouraged to make a \$2.00 donation to the club to help off-set costs of making the program available.

The meeting was called to order at 6:00PM by President Doug Wiest and the agenda was adopted. Also in attendance at the meeting was Russ Crane.

Vice President Report (Terry)

Terry reported that the next Membership Meeting will be held on June 11, 2014 at Hody's Bar and Grill in Middleton. We will have a speaker from Donald County Park, site of our August 23 walk in Mt. Horeb. The August 13 Membership Meeting will be held at Lakeview Park in Middleton.

Terry is still waiting to hear back from Immanuel Lutheran Church on Madison's east side to see if we can use their facilities for our December Membership Meeting/Holiday Party on Sunday, December 7.

Secretary Report (Mary)

The minutes of the last Board meeting held on March 12th 2014 had been previously emailed to the Board. There were no corrections or additions to the minutes, and they were approved as distributed.

Mary told the Board that she would be unable to take minutes at the June 11 Membership Meeting because of the Alaska trip. Karen Reger volunteered to take minutes at that meeting at Hody's Bar & Grill.

Mary asked for clarification on walking fees for young children who are accompanied by a fee-paying adult on our sanctioned walks. We have a \$2.00 fee for youth who walk for AVA credit, but what about those youth that are not interested in stamping books and walking for credit? The Board recommended that the adults not register and fill out start cards for these young children who are not walking for credit. Then, no AVA fees will be assessed, and the children can walk for free.

Treasurer's Report (Diane)

Diane had emailed the Treasurer's Report to the Board. The balance on April 9, 2014 was \$1,146.98. Since that time, income totaled \$1,449.00 and expenditures were \$836.49. It should be noted that of the \$1,449.00 in income reported, \$232.00 is related to prepaid fees collected for another club's walks in Alaska. So, the \$232.00 should be recorded as an expense on the July Treasurer's report. The current checking account balance on May 14, 2014 is \$1,759.49. Of that balance, \$1,000 is restricted for trips. The report also noted that pre-paid expenses of \$3,000 had been made for five years of website hosting by the Stevens Company. It was decided to modify some details on the May Treasurer's Report and the final report will be discussed at the July Board Meeting.

Russ Crane suggested that Diane record all Rendezvous checks in one category called "Rendezvous". Russ will take care of the detailed accounting of the Rendezvous event and provide that to Diane at a later date.

Membership Report (Tom Doyle)

Tom reported that eight new members joined at the DeForest Walk.

Walk Box Coordinator (Bruce)

Bruce said there is not much to report at mid-year for his position.

<u>Trailmaster Report</u> (Don)

First, Don reported that the DeForest Walk had 109 participants, our highest participation for a traditional event since we had a Tator Tours group visit us for a Wisconsin Walking event in 2007.

Second, Don said he is expecting that walkers from around eight other states will participate in our Tri-State event on May 17 and 18. He thinks that the busiest time for walker registration at the Platteville Chamber of Commerce will be from 8AM to 10:30AM. Our club will be well-prepared with six different stations manned by volunteers to collect cash, register walkers, stamp books, and handle the Saturday evening meal sign up for Benvenuto's in Platteville.

Don discussed participating in the AVA nationwide walking effort planned for 10:11AM on December 13, 2014. It was thought that a modified version of the Capitol Walk that starts at the Inn on the Park might be doable that Saturday in December.

Then we discussed the draft of the 2015 walk schedule that Don had prepared. The tentative schedule notes West Towne on January 19, East Towne on February 21, a Middleton Pie Walk on March 14, Whitewater on April 18, and Evansville on May 16. Our club agreed to participate in Walk Wisconsin again in Stevens Point on June 5.

Gilbert Engels, President of the Menominee River Volkssport Club has agreed to help plan walks in Oconto County and Green Bay (Brown County). It was decided to plan the Oconto County walk for Saturday, July 18 with a noon start time. Then, arrangements could be made to stay overnight in Oconto and walk in Green Bay on Sunday morning, July 19. A Verona walk is scheduled for August 15.

Another walking weekend that includes Menominee, Dunn, and Chippewa counties is planned for September 19 and 20. Our club's 20th anniversary in October may be celebrated with a walk covering Madison's west side parks on October 10. Finally, Don is planning a Governor Nelson State Park Moonlight walk on October 23 or 24.

Publicity (Karen)

Karen had nothing to report.

Volunteer Coordinator (Tricia)

Tricia has formed a Volunteer Recognition Committee consisting of Ronni Guski, Kathleen Larson, Tom Doyle, Heidi Pierckert, and herself. They plan to solicit nominations for volunteer recognition awards that can be granted by North Central Regional Director Phyllis Olson at the Regional Rendezvous in early October. The volunteer recognition awards will be existing AVA volunteer awards. Tricia said the committee plans to use the weekly club emails and July/August Newsletter to ask club members for nominations. The committee will vote on the nominations and submit them to Phyllis by September 1.

Tricia also said that the Volunteer Recognition Committee may ask for a budget in future years to award those volunteers recognized with items like gift certificates or coupons.

New Business

Proposed Criteria for Continuation of Year Round/Seasonal Events

Don had sent the Board some proposed criteria to consider when deciding to renew year round and seasonal events. It is hard to quantify the "breakeven point" for individual walks. Each year round walk currently has a fixed yearly cost of \$40.00 consisting of sanction fees paid to the AVA. The seasonal (or three quarter) walks require \$35.00 a year to the AVA for sanctioning fees. Our club collects three different amounts from participants: \$3.00 for cash credit walkers, \$2.50 for frequent coupon/credit walkers, and \$2.00 from non-credit walkers. Then, we must pay AVA \$1.25 for each walker who registers for our events. The Board agreed with Don's simplified "breakeven" number of participants of 30 for year round events and 25 for seasonal events. As Don stated, though, actual costs to the club exceed these sanction and participation fees. It is hard to quantify the postage, copying, and walk box supply expenses.

Russ followed up Don's report with a couple of graphs depicting the 2013 participant numbers for each year round and seasonal event. However, after review of the numbers, Russ observed that perhaps the most important criteria to use in approving year round and seasonal events is the volunteer effort required to maintain each walk and walk box. Many on the Board agreed with that observation.

At the end of discussion, the Board did not reach any definitive criteria to use before discontinuing a year round or seasonal walk. But, the Board will keep this discussion in mind when approving the sanctioning of 2015 year round and seasonal events at the next Board Meeting on July 9.

The next Board Meeting will be on July 9, 2014 at the Lakeview Branch Library. The Next General Membership Meeting will be on June 11, 2014 at Hody's Bar & Grill. The next special walking events are the Tri-State Walks on Saturday and Sunday, May 17 & 18, and the Lake Kegonsa State Park Walk in Stoughton on Saturday, June 28.
