Monona Walk – May 11

We have another Saturday Walk and Eat in May, but we'll take a break in June from the Saturday Walk & Eats so some of our members can attend the AVA National Convention in Albany, NY from June 8-16. Following that, the Spring Green/Richland Center Walking weekend will be held from June 22-23. Saturday Walk and Eats will return with two scheduled in July!

Saturday morning, May 11 will find us walking in Monona. We'll meet in the parking lot of Monona City Hall, the start point, located at 5211 Schluter Road to register for the walk. Right now we are only planning to do the 11k route; if anyone would like to volunteer to lead the 6k Monona route, let me know and I'll add that information in an email update. Walkers should meet at 8:45 a.m. to register for the walk; plan to start walking at 9 a.m. After the Monona walk we'll eat at Tully's II located at 6401 Monona Dr. (near the intersection with W Broadway) Here is a link to their menu: <http://tullys2.com/menus.html>

Cottage Grove Walk

This will be our first-ever walk in Cottage Grove and will pass through or beside seven community parks, through several residential sections, and follow a section of the Glacial-Drumlin Trail. As a special treat a Ragnar Relay (this event involves teams of various sizes running about 200 miles covering two days and one night) from Chicago to Madison will be taking place on the same day as our walk and will be running on our trail section following the Glacial-Drumlin Trail. We have been assured that this will not affect our use of the trail but may add some spectators and activities along about a mile of our walk.

There will be 6k and 11k options for this walk with registration available from between 8 am and noon. All walkers need to have completed their walk by 3 pm. Those wishing to walk as a group should meet at the start point at 9 am. To reach this walk follow I-94 east from Madison and turn right at exit 244 onto Hwy N. Follow Hwy N south for 2 miles into Cottage Grove, crossing Hwy BB (Cottage Grove Rd). Turn right on Weald Bridge Rd, then take third right on Bonnie Rd, then take first left on Lori Ln to Community Park. Ample parking is available in the park.

Middleton Walk - Update

The Middleton Parks and Recreation Department has been placing a high level of emphasis on opening the bridges along the Pheasant Branch Nature Preserve with remarkable results. By the end of April all bridges which had been made impassable by the August 2018 flooding will again be open to pedestrian traffic, eliminating the need to cross the stream five times on stepping stones. Unfortunately, the continued high level of Tiedeman Pond has prevented repairs to the boardwalk along the eastern end of the Pond. It will be repaired as soon as workers can access the damage areas, but an alternative route is available until then.

Walking in Frank Lloyd Wright's Footsteps With a Walking Weekend **By Don Suloff**

Frank Lloyd Wright, born in 1867, is recognized as one of America's most influential, if controversial, architects. Wright's grandfather emigrated from Wales in 1858 and settled on property near Spring Green, Wisconsin, where Wright later developed his acclaimed "Taliesin". After living in Oak Park, Illinois, from 1898 to 1909 where he developed his Prairie School architecture concept, Wright moved to the Taliesin property in 1911 following a marital scandal, and despite periods living elsewhere, lived or interacted with this property the rest of his life, dying in 1959. Although Wright-designed buildings can be found in many parts of the U.S., many of his most famous designs can be found in Wisconsin. Inspired by Wright's creativity, the Dairyland Walkers will be hosting traditional walks in five different Wisconsin cities during 2019 showcasing Wright-designed buildings.

For many years the Dairyland Walkers have hosted a weekend of walking featuring at least two walks on a Saturday and Sunday. This year our walking weekend will be in Richland Center on June 22 and in Spring Green on June 23. Frank Lloyd Wright is known to have been born in Richland Center, Wisconsin, on June 8, 1867—the site of his birth is debatable with six possible locations suggested within city limits and a seventh nearby. The Dairyland Walkers' Richland Center walk will feature 5k and 10k options and will pass six of these sites and the only Wright-designed building in town. The A. D. German Warehouse, built in 1917 within Wright's "natural" period (1911-1924), was the result of Wright exchanging the building design for unpaid grocery bills and was built to house German's wholesale grocery business. Widely believed to be of Mayan influence, the building features plain brick surfaces broken by vertical narrow window slits. The facility is significant as an example of poured concrete construction and rests on a pad of cork for stability. Registration for the walk will be available at the Robert Retrum Shelter in Krouskop Park between noon and 3 pm, with all walkers to have completed their walk by 5 pm. Those wishing to walk as a group should meet at the start point at 1 pm. To reach this walk follow Hwy 14 west of Madison to Richland Center where Hwy 14 joins Hwy 80 and passes through Richland Center. Continue on Hwy 80 when Hwy 14 splits to the left. Turn left on 8th, then right on Jefferson into Krouskop Park and the Robert Retrum shelter start point at the end of the road. Ample parking is available at the start point. Tours of the A. D. German Warehouse are available on Sundays between 11 and 3 for a fee of \$15 and tours last about 45 minutes. Tours should be confirmed at (608) 649-5034. Volunteer Opportunity: Help register walkers and take payments between noon and 1:30 am at the start point. Contact Don Suloff at suloff@tds.net if interested in helping on this walk.

Walkers will then drive to Spring Green for the Sunday walk. Although it will not be difficult to commute from the Madison area, all are encouraged to spend the night in Spring Green for socializing with fellow walkers. To facilitate spending the night, single (king bed - \$105.40) and double (2 queen beds - \$124.39) rooms have been blocked at the Round Barn Lodge in Spring Green and will be held for the "Dairyland Walkers" until May 22, 2019. The Round Barn Lodge is located at E4830 Hwy 14 and can be reached at (608) 588-2568. We have not reserved dining arrangements but would encourage walkers to meet informally at the Wisconsin Riverside Resort located at S13220 Shifflet Road about 6 pm.

The Spring Green walk will feature 5k and 10k options with registration at the North Park Shelter between 8 am and 11 am with walkers to have completed their walk by 1 pm. Those wishing to walk as a group should meet at the start point at 9 am. Although there are no Frank Lloyd Wright designed buildings in Spring Green, his influence is obvious in many of the buildings along our route. The BMO Harris Bank was designed by Wright's son-in-law and chief architect at Taliesin. To reach the walk turn south from Hwy 14 to Hwy 23 in Spring Green and follow Hwy 23 for 0.4 miles. Turn right on E. Daley St and follow it for 0.2 miles, then turn right on Park to the start point at the North Park Shelter. Ample parking is available in the park.

There are a number of Wright-related sites a short drive from Spring Green including the Unity Chapel, Taliesin, and the Wyoming Valley School. The most famous of these is Taliesin where Wright spent most of his years between 1911 and 1959. Relatively expensive tours of Taliesin are available and can be made at www.taliesinpreservation.org/tour. A variety of tours are offered but sell out early. The Wyoming Valley School Cultural Arts Center is open on Saturday and Sunday from 10-2 for a free will donation. Walk the Fox River Valley

Four all new walks in Appleton and Neenah are available to enjoy in 2019.

The Appleton 5K walk largely overlaps Appleton's self-guided "Fox Trot Trail" on city sidewalks and paved trails. The scenic loop takes walkers through the downtown business and entertainment district, the Lawrence University campus, and along the historic riverfront with attention to 16 points of interest highlighting Appleton's unique history and the beautiful Fox River.

The Appleton 10K also overlaps the city's "Fox Trot Trail" and adds a walk through Appleton's "City Park Historic District" that highlights late 19th and early 20th century residential architecture.

Directions for the Appleton 5K and 10K include a QR code that walkers can use to open a "Fox Trot Trail" guidebook.

On Saturday mornings from mid-June through mid-October both 5K and 10K routes take walkers through the Appleton Farmers Market along four blocks of College Ave. Please note that pets are not allowed in the farmers market so walkers with 4-legged companions will need to detour around that section of the route.

The Neenah 6K and 10K start point is now at the DoubleTree by Hilton Hotel in downtown Neenah. Weekday parking in downtown Neenah is highly regulated and time limits are strictly enforced. The best option is "no time limit" street parking on E Columbian Ave. one block behind the hotel start point. The Neenah 6K starts with a short walk through Neenah's historic downtown and then connects with the "Loop the Little Lake Trail" that circles the southern half of Little Lake Butte des Morts on a network of paved trails and city sidewalks. Highlights of the trail include crossing four trestles, one of which is the longest pedestrian bridge in

Wisconsin, and passing close by a Fox River island that is home to a nesting colony of white pelicans.

The Neenah 10K also circles Little Lake Butte des Morts on the "Loop the Little Lake Trail" and adds a walk through "Doty Island" that highlights seven homes of historical interest as examples of the extravagant social lifestyle of industrial elites in the late 19th and early 20th centuries.

Little Lake Butte des Morts, a widening of the Fox River, was the scene of violent conflicts between native peoples and the French Empire in the early years of the 18th century. The Meskwaki, given the name "Fox" by the French, fiercely resisted the French incursion into their territory. In 1716 and again in 1730 a force of close to 1000 French soldiers and native allies attacked the Meskwaki's fortified village on the east shore of Little lake Buttes Morts, close to the "Loop the Little Lake Trail" pathway near where Menasha's Fox River lock is located. The 1730 battle resulted in the surviving Meskwaki being exiled from what is now Wisconsin.

A short article about the tragic conflict between the Meskwaki and the French is worth reading to provide historical perspective as walkers circle the now peaceful waters of Little Lake Butte des Morts: <https://www.wisconsinhistory.org/Records/Article/CS1728> Both the Neenah 5K and 10K routes offer the unique opportunity to pass through parts of three communities (Neenah, Menasha, and Fox Crossing) all on a single walk.
