Previously scheduled group walks on May 2 (Arboretum) and May 9 (Monona) are canceled due to the extension of the Wisconsin Safer at Home order through May 26.

Hopefully by Saturday morning, June 27 we will be able to walk outside as a group to Picnic Point in Madison. We'll meet at the start point of the Picnic Point walk, inside the lobby of the Best Western PLUS InnTowner, located at 2424 University Ave. at around 8:45AM to register for the 10k walk. ## Walking Dairyland Walker Year Round and Seasonal Routes While Social Distancing! By Jerry Wilson

Good walking weather is here in Wisconsin. Those of us that are getting out to walk anyways could walk the Dairyland Walkers routes without going into a start point business location. We can offer a process where walkers get out now to do the club's 22 year round and seasonal walks, and later stamp your books and pay your participation fee. Under AVA rules and to comply with liability insurance requirements walkers need to sign the waiver. So, following is the suggested process to follow:

1. E-mail Jerry Wilson at [jpatw4@gmail.com](mailto:jpatw4@gmail.com) as many days as possible before planning to walk a specific route:
  - a. Identifying which walk you wish to walk, and the distance desired.
  - b. Attach a completed and signed (Waiver) Official Event Start Card form: See Newsletter **Attachment D**
2. A list will be compiled of walkers and shared with each POC. An email will return to you with an attached copy of the walk directions to be completed per your schedule. Either print the directions in advance or access directions on a smart phone when you begin to walk.
3. When walk boxes are again accessible, stop in, stamp your books, complete the registration log, an envelope, include payment and a copy of the submitted (waiver) Official Event Start Card and follow directions in each start box.  
If you no longer have a copy of the waiver start card, or could not print it at home, complete a new start card from the box.

**Back to High Cliff State Park****By Don Suloff**

Eight years ago the Dairyland Walkers visited High Cliff State Park to enjoy the myriad park trails and some spectacular views of Lake Winnebago. Those who participated in that walk will remember it less for the views and much more for the rain, obscured views, and muddy trails! Although we can't guarantee sunshine and clear skies, we clearly hope that this kick-off to a walking weekend provides much better circumstances than we experienced in 2012. Of course, now we need to be concerned about Covid-19, but we will assume that we will be good to walk on Saturday, June 13<sup>th</sup>, at High Cliff.

Registration for the walk will be at the Pines Shelter in High Cliff State Park on Saturday, June 13, between noon and 3 pm with all walkers to have completed their walk by 5 pm. There will be 10K and 6K options with the 10K walk rated at 3C and the 6K rated at 2B. The walk features trails and scenery of High Cliff State Park on the shores of Lake Winnebago. It includes spectacular views of the lake, old lime kiln ruins, a series of Indian Mounds, an abandoned lime-stone quarry, a cliff-top observation tower, and an historic cemetery.

To reach the start point, follow US 151 north from Madison through Fond du Lac and past the Village of Brotherton. Turn left on WI 55. In Sherwood, turn left on Clifton Rd which becomes Spring Hill Dr. Enter High Cliff State Park (park sticker or pass is required) to the start point at the Pines Shelter.

**Sheboygan – A Walk by the Water****By Kristi Kenyon**

Make June 13-14 a walking weekend! Enjoy High Cliff State Park on Saturday June 13 and then stay overnight in the Sheboygan area. On Sunday, June 14, we'll be walking in Sheboygan on Lake Michigan. Our walk will start at Durand Park, 901 Broughton Dr, right on the lake. Walk through 4 parks: Deland, Sheboygan Peace, Fountain, and Rotary parks. Pass two arts destinations: John Michael Kohler Arts Center (JMKAC) and Above & Beyond Children's Museum. (Check out the decorated main restrooms at JMKAC if you have time!). Stroll by two beaches: Deland Park & South Side Municipal beaches. Enjoy kilometers of boardwalks along Lake Michigan & the Sheboygan River. You'll even walk through shipwreck remains! Restrooms and water at start point & along the trail.

Walkers may register between 8 am and noon and are requested to have completed the walk by 3 pm.

To reach the walk, from I-43 Northbound, take Exit 126A. RIGHT on HWY 23 towards Lake Michigan. Hwy 23 becomes Erie St, RIGHT on 4th St, LEFT on ONTARIO St, & RIGHT on BROUGHTON. LEFT into DELAND PARK at Wisconsin Ave entrance, drive to end of parking lot, by the Deland Park Community Center.

Since this event is sanctioned for multiple days you could also walk again on Saturday, and Sunday, walking multiple days requires paying the walking fee for each day, but this will help the local club and the national club.
